

# Great response to the **Judicial Review Appeal**

Judicial Review (JR) appeal challenging the Council's decision to approve a school on the White Lodge site. MANY THANKS to all who have contributed so far.

## We're past the half-way mark (£20,000)

Our first target was £10,000 for Stage 1 of the JR. Now we have doubled that. We need £40,000 to see the JR through to the end. So we still have a way to go but this is a very good start indeed. The contributions are very varied since people give according to their means. With that in mind it is clear that many have been very generous. We are aware that some residents have given generously even when reliant on modest incomes – we are very grateful for that.

## If you haven't yet contributed

Please give the matter careful thought if you have not yet contributed. Our argument all along has not been against the school but against its inappropriate location on Metropolitan Open Land (MOL) and the large increase in unsustainable traffic which would result. Building on MOL requires very special circumstances to obtain and this has not been demonstrated.

So the question is do we just accept anything that the Council does in our name (we elect its members and we pay the Council Tax) or do we stand up and protest when we see wrongdoing?

In addition it is clear from recent public documents that the current Council has a vision of high-rise Hounslow and scant regard for building restrictions on Green Belt land. This approach would destroy the character of areas such as Osterley. We need to say "no" before this process gets under way.

Right now contributing to our Judicial Review is your most effective way of doing that. If you haven't already contributed then please consider doing so.

# **Pre-application letter sent to the Council**

Our barrister has sent a pre-JR application letter to the Council setting out the reasons for seeking the Review and asking them to reverse their decision before the JR gets underway. The Council has replied indicating that it does not intend to do so.

#### Setting out our case

Our case for a JR has now been completed and filed with the High Court. We think the case is very strong and will give further details as soon as we can.
